MANAGEMENT DISCUSSION OF FUND PERFORMANCE

Results of Operations

The ETF's net assets increased from \$12.2 million at the end of 2023, to \$22.3 million as of June 30, 2024. The increase was primarily due to subscriptions.

The trailing 12-month median dividend growth of the portfolio companies was 11.4% at June 30, 2024 compared to the S&P/TSX Composite Total Return Index (the "Index") constituent median 5.2%. Over the next 12 months, our model is predicting median dividend growth of 12.4% for our portfolio companies. This compares to the median of the Index constituents of 3.4% as forecast by consensus.

The ETF underperformed the Index during the period. For the six-month period ended June 30, 2024, the ETF returned 4.3%. The Index returned 6.1% during the same period. The primary contributors to relative returns during the period were the portfolio's underweight and stock selection in Financials, the overweight and stock selection in Industrials as well as stock selection in the Consumer Discretionary sector. No exposure to Energy, stock selection in Information Technology and both the overweight and stock selection in Real Estate were amongst the primary detractors from returns.

From an absolute return perspective, Dollarama Inc., Thomson Reuters Corp. and TMX Group Ltd. were among the largest contributors during the period.

Open Text Corp., Enghouse Systems Ltd. and TELUS Corp. were among the largest detractors on an absolute basis during the period.

During the period the ETF exited an investment in Visa Inc. and initiated a new position in Broadcom Inc. The change was made primarily due to our view that there is more upside in Broadcom from a valuation perspective for similar levels of dividend growth as Visa and that Broadcom represents a scarcer opportunity relative to the Canadian landscape which has a dearth of opportunities to the AI theme. We also exited our investment in Canadian Pacific Kansas City Ltd. due to a lack of dividend growth. Existing positions in TELUS Corp., Premium Brands Holdings Corp., Open Text Corp., FirstService Corp., Intact Financial Corp., Canadian National Railway Co., Colliers International Group Inc., Zoetis Inc. and InterRent Real Estate Investment Trust were increased. Positions in Dollarama Inc., Stella-Jones Inc. and Thomson Reuters Corp. were decreased. These transactions occurred as part of our regular quarterly rebalancing process and, as a result, a couple of positions were both added to and trimmed during the period.

Recent Developments

The Bank of Canada was the first central bank in the G7 to cut rates in an attempt to stimulate growth in a sluggish economy as domestic consumers continue to struggle particularly on concerns with higher interest rates and debt levels.

In a highly cyclical and concentrated market like Canada, it is important that we continue to focus on following our investment process and the fundamentals of the company's held in our portfolio. That focus will ensure our investors will benefit from a collection of resilient, high-quality businesses that are growing their dividends at high rates - regardless of what the macroeconomic environment may bring.

Despite a challenging environment, we view the long-term results of the strategy relative to the S&P/TSX Composite Total Return Index as validation that our approach can outperform the market over the long-term.

Related-Party Transactions

Manager, Trustee and Portfolio Manager

Bristol Gate Capital Partners Inc. ("Bristol Gate") is registered as a portfolio manager and exempt market dealer in the provinces of Ontario, Quebec, Alberta, British Columbia and Manitoba and is also registered as an investment fund manager in the Provinces of Ontario and Quebec.

Bristol Gate is also registered with the U.S. Securities and Exchange Commission as an investment adviser under the Investment Advisers Act of 1940. Bristol Gate is the Manager, Trustee and Portfolio Manager of the ETF. Bristol Gate is responsible for the ETF's day-to-day operations and provides investment advice and portfolio management services to the ETF. Bristol Gate is only paid a management fee by the ETF as compensation for its services. The management fee is calculated and accrued daily and is based on a percentage of the net asset value of the ETF.

The ETF paid management fees to the Manager, inclusive of HST, of \$69,224 for the period.

The Manager has chosen to absorb certain operating expenses for which the ETF is responsible.

The Manager has appointed the Independent Review Committee (IRC) established under the Canadian Securities Administrators' National Instrument 81-107 Independent Review Committee for Investment Funds. The mandate of the IRC is to review and provide recommendations or approval, as required, regarding certain conflict of interest matters referred to it by the Manager on behalf of its managed ETFs. The IRC consists of three members, all of whom are independent of the Manager. Members of the IRC receive fees for services rendered. These fees and expenses, plus associated legal and insurance costs, are allocated among the ETFs managed by the Manager. During the period, the ETF did not rely on a positive recommendation, or approval, of the IRC with respect to any related party transactions.

Management Fees

The ETF pays a management fee, plus applicable taxes, to the Manager based on the annual rate of 0.70%, before GST/HST, of the net asset value of the ETF. This management fee is calculated and accrued daily and payable on the last Valuation Date of each month or on such date as the Manager may determine.

The management fee for the ETF compensates the Manager for providing portfolio advisory and investment management services to the ETF and for providing or arranging for other managerial and administrative services to the ETF including: arranging for payment of operating expenses; providing office space, facilities and personnel; preparing financial and tax information; preparing and providing financial statements, MRFPs and other required reports to unitholders; ensuring compliance with regulatory and exchange listing requirements; determining distributions; communicating with unitholders and calling meetings of unitholders; administering the purchase, exchange and redemptions of ETF units; and contracting with third party providers of services to the ETF.

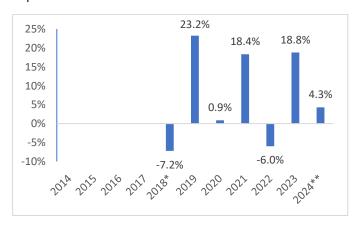
